"Voluntary assignments for the benefit of creditors, on the other hand, as practised in this and other States, do not originate in the State statutes, but in the common-law power of the debtor to dispose of his property. The statutes of this State passed in 1800, and subsequent acts, regulate to a certain extent this power of distribution, and provide various securities therefor. To a considerable extent, therefore, these statutes, and assignments made in conformity with them, though they make no provision for the discharge of the debtor, do cover in part the original purpose of bankruptcy laws, namely, the equal distribution of the debtor's property among his creditors. The New York Statutes, nevertheless, allow, besides preferences to employees, preferences to other creditors, at the debtor's option, to the extent of one-third of the assets (see Central N. Bank v.
