The case law is extensive (though introductory), and very current. This edition of A Student's Guide, for example, contains scores of citations to primary authorities?including many decided just within the past year. This new edition also contains fulsome discussions of both Twombly and Iqbal, as well as the Supreme Court's other recent opinions on Civil Procedure concepts.
- PLUS... A Helpful Orientation to the Rulemaking Process: A Student's Guide also includes a brief orientation for students to the process of federal rulemaking, how the Rules originally came into existence, and how they are amended.
